### **Examinations In Review**

## January through December - 2018

The NBRC Board of Trustees makes it a priority to ensure all examination candidates experience the best possible testing service. To make our credentialing examinations as convenient as possible for candidates, our testing agency, PSI, offers morning and afternoon sessions Monday through Saturday at over 300 locations nationwide.

From January 1 through December 31, 2018, the NBRC administered 28,765 examinations and awarded 14,451 new CRT, RRT, CPFT, RPFT, CRT-NPS, RRT-NPS, CRT-SDS, RRT-SDS and RRT-ACCS credentials.

The following chart is a breakdown, by exam and credential, of how many candidates attempted each examination and how many were awarded a credential.
